#### KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, residents of the State of California, do hereby voluntarily associate ourselves together for the purpose of incorporating a privite corporation under the laws of the State of California.

AND WE DO HERERY CERTIFY,

FIRST: That the name of said corporation shall be CALIFORNIA WRITERS' CLUB.

SECOND: That the purposes for which said corporation is formed are:

To associate men and women in a distinct way with literature and art;

To encourage fellowship, afford inspiration to, and furnish a meeting place for, people interested in liferature and art;

To stimulate and encourage literary and artistic efforts by assisting, procuring and taking over the production, exhibition and publication of such works as shall be deemed worthy, and of sufficient value, to warrant such action in the judgment of the corporation.

THIRD: That the place where the principal business of said corporation is to be transacted is in the City of Oukland, in the County of Alameda, State of California.

FOURTH: That the term for which said corporation is to exist is Fifty (50) years from and after the date of its
